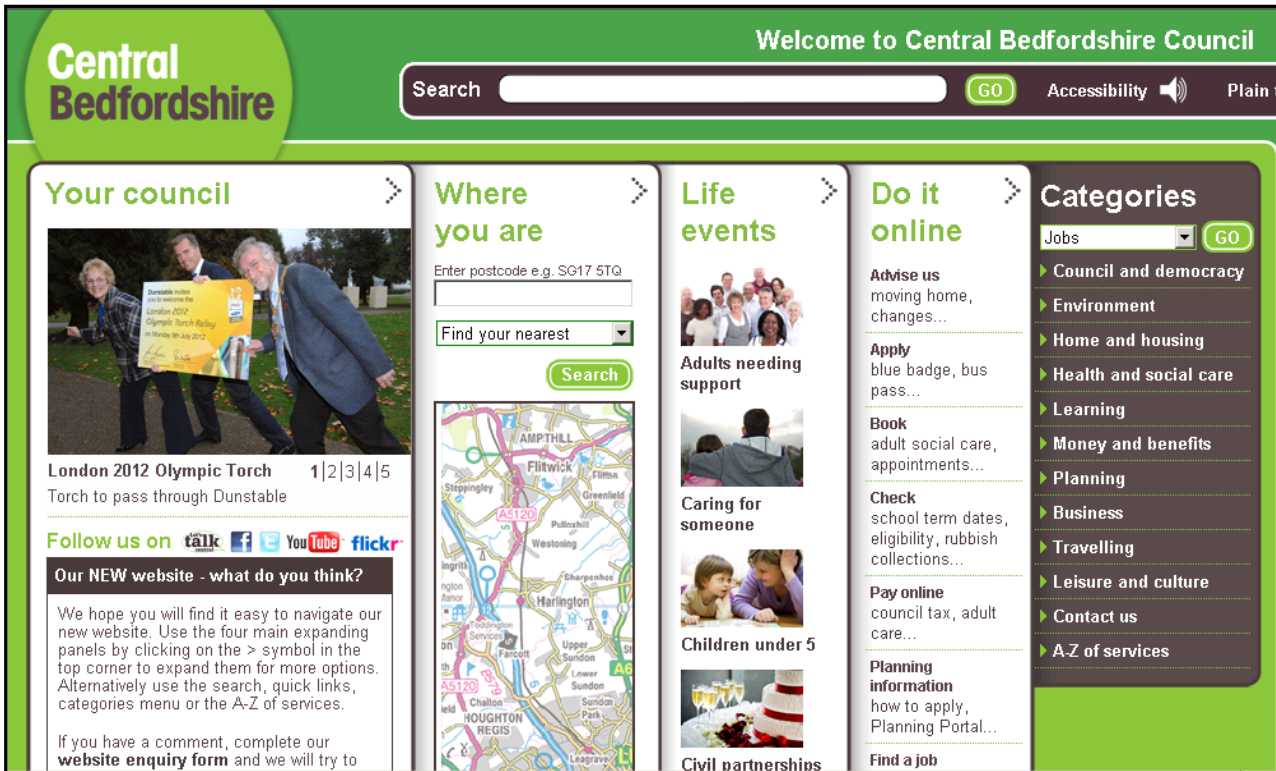

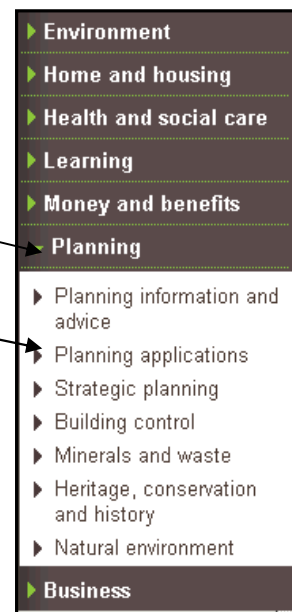
## Procedure for commenting on a planning application

We can only take into account issues that are proper planning matters. Generally the main ones are as follows: Amenity (impact on neighbours), Design, Highways, Policies, History.  
Issues that normally wouldnt be taken into account: Personal circumstances, Whether the applicant or landowner is known/unknown, liked/disliked etc, The right to a view over another person's land.

## Finding the application

In order to comment an application you will need to find the application in the system:

If you know the application number (you will find this number on the correspondence that you have received from us) you can use the 'Application Quick Search'. Please enter the number as shown precisely on the correspondence.

### Application Quick Search

Type in the planning application number in the following format: YY/000000 to find the matching application. Please enter the number as shown on the correspondence that you have received from us.

To search for a street name, town or postcode use 'Search by Address'.

### Search by Address

Type in a full or partial address using commas, to find all matching planning applications. Please see example: 50 Any Street, Any Town, Postcode. If the search is unsuccessful, try road name, town or postcode only.
