#### What is the Central Bedfordshire and Luton JLAF?

The Joint Local Access Forum (JLAF) is an independent statutory advisory group which works on improving public access to land in Central Bedfordshire and Luton for all types of open air recreation. This group of local volunteers has attended six meetings over the last year to discuss outdoor access matters and many of the issues arising from the Countryside and Rights of Way Act 2000.

The forum is made up of people with wide experience of a diverse range of outdoor access interests. The members are drawn from countryside user groups, farmers and land managers and other relevant interests. There is a requirement to have a balance of interests to enable the group to develop actions which will improve outdoor access in Central Bedfordshire and Luton for all.

### 10th Anniversary celebration



The forum celebrated the 10<sup>th</sup> Anniversary of the creation of the former Bedfordshire and Luton Joint Local Access Forum, at a joint meeting with the Borough of Bedford LAF. Members of Milton Keynes LAF also attended the meeting which included very informative presentations on:

### Luton – Dunstable Busway cyclepath

The formal opening of the Luton – Dunstable guided busway took place on Tuesday 24<sup>th</sup> September 2013. The forum welcomed the creation of a cyclepath along the access track for the busway and has worked with Luton Borough Council and Central Bedfordshire Council to ensure that the surface and structures are appropriate for cycle use.

### Central Bedfordshire Council – Rights of Way updates

The forum has been very pleased to receive regular updates from the Rights of Way team at Central Bedfordshire Council on progress made over the last year. This has included information on BVPI results and progress on the strategy to replace stiles with gates/gaps. This is a key priority for the forum which has worked hard over recent years to promote least restrictive access on rights of way. It is good to see the number of stiles reducing through a combination of the hard work of rights of way officers, amenable landowners and committed volunteers.

### Outdoor Access Improvement/Rights of Way Improvement Plans

JLAF members have reviewed the Luton Rights of Way improvement plan and have continued to provide input to the Central Bedfordshire Council Outdoor Access Improvement Plan (OAIP) 2013-31. Following adoption of the CBC plan the forum have now switched their focus to monitoring progress against the actions within the plan.

### Mapping of excluded areas

The forum has been working closely with Central Bedfordshire Council and Luton Borough Council to ensure that Definitive Maps are produced for the currently excluded areas of Luton, Biggleswade and Dunstable. It recognises the risks of these non-mapped areas for the future and is pleased to note that work is now planned by both authorities to get Definitive Maps produced for all 3 areas.

### JLAF visits

The forum meets at a variety of venues to provide opportunities for members to visit interesting sites and to balance travel times for members. During the summer months we try to hold meetings at venues where a short walk can be undertaken before the meeting. This year the forum visited Mount Pleasant Golf Club in Lower Stondon. Members were taken on a very enjoyable and informative walk around the course and were able to see how the Golf Course is managed to reduce the need for fertilisers and to maximise biodiversity. ### Non-motorised Users forum for the Woodside Link (A5-M1)

A substantial amount of development is planned for the area north of Houghton Regis which includes a new road linking the A5 to the M1 (known as the Woodside link). The road should improve traffic congestion in the area and support new housing developments and economic growth. The forum have driven the establishment of a non-motorised users forum for the link road and surrounding developments to seek to ensure that the needs of non-motorised users are considered within any proposals. An initial meeting was very positive and noted the need to ensure that wherever possible consideration is given to improvement of the rights of way network and any crossings for non-motorised users.

### Houghton Hall Park – HLF bid

Central Bedfordshire Council was very pleased to receive a Stage 1 Development Grant of £215k from the Heritage Lottery Fund for a Renaissance and Renewal Project at Houghton Hall Park, Houghton Regis. Kim Owens, Senior Fundraising Manager gave a very informative presentation on the work being undertaken to submit a Stage 2 bid for over £2m of funding to

- bring together different user groups
- increase accessibility and pride
- celebrate park heritage
- improve facilities to meet the needs of a growing modern community



The forum provided a number of useful suggestions for items to be considered as part of the bid and provided their support to the bid. We look forward to hearing a successful outcome in due course

### Paths for Communities

The forum was proud to support a successful bid to the Natural England Paths for Communities scheme for £26,495 towards the creation of a new cyclepath to the west of Biggleswade. The path, which was created by dedication with the landowner, uses an existing A1 underpass to provide a safe link from Biggleswade to Shuttleworth college, local tourist attractions and the village of Old Warden.
