NON DOMESTIC RATES Application for Charitable Relief



Advice and Guidance

Registered charities or bodies exempted from becoming charities will be entitled to 80% Mandatory Relief providing the premises are wholly or mainly used for charitable purposes by that charity or that charity with other charities.

Central Bedfordshire Council, at its discretion, can award a further 20% maximum Discretionary Relief to those organisations receiving Mandatory relief. The Council also has the discretion to grant up to 100% Discretionary Relief in respect of the following:

- Property occupied for the purposes of an organisation not established or conducted for profit and whose main objectives are either charitable, philanthropic, religious, concerned with education, social welfare, science, literature or the fine arts.
- Property occupied by a club, society or other organisation not established or conducted for profit which is wholly or mainly used for purposes of recreation.

How the Council will assess your application

- Each case will be considered on its own merits
- Applications for 100% Discretionary Rate relief are considered on a monthly basis by the Head of Revenues & Benefits
- All information provided for Discretionary applications will be presented in a report for consideration by the Head of Revenues & Benefits
- You will be advised in writing of the outcome of your application

How to apply for Charitable Relief

Complete the attached form, and return it to the Revenues Section at Central Bedfordshire Council.

Please enclose the following with your application:

- Copy of your Memorandum and Articles of Association
- Copies of your latest audited accounts

Whilst you are waiting for your application to be considered, you should continue to pay your rates in accordance with your bill unless you have agreed a separate payment arrangement with the Revenues Section.
