Introduction

The 1 April 2009 brought about a landmark change in how public services are delivered to the people of Central Bedfordshire with the creation of the new unitary Council. Our vision for Central Bedfordshire is based on bringing local government closer to communities. We can't do this on our own and working together with Parish & Town Councils is vital to achieving this vision.

All Parish & Town Councils in Central Bedfordshire were invited to attend our first Central Bedfordshire Parish and Town Council Conference. The conference was an opportunity to build on our existing relationship and ensure it is productive and rewarding in the future.

At the conference over 100 Parish & Town Council representatives had a chance to network with colleagues and talk to our front-line service delivery teams, meet our Directors and Assistant Directors and talk with us about how we can work better together for the benefit of our residents.

This report provides a write up of all the comments and feedback we received plus answers to every question that delegates left on the question cards provided.

We are building your key issues into our forward thinking to ensure that many of the issues you raised will be addressed within our service plans. We have already actioned some of the feedback, such as arranging more Project Involve training and using the feedback to inform a first draft of our community engagement strategy.

Thank you to all those of you who were able to participate as your involvement is critical to our joint working for the benefit of all our communities. We will be able to update you on progress at the next Town & Parish Council Conference, which will be held on 4th November 2009 at Priory House, Chicksands. Please put this date in your diaries.

Finally, these conferences are not one-off events and we will continue to consult with you in between times through a variety of means.

Community Engagement and Development Support

Delegates heard about the model being developed to better engage with our communities, and how the Council will work with and support Parish & Town Councils. After this the second roundtable discussions considered how Parish & Town Councils could work together, and with the Council, to solve community issues, improve community led planning and deliver devolved services. The discussions also considered what additional support the Council should provide. The discussions were followed by a voting exercise on the preferred approach to tackling local problems and the benefits of large events for discussing key issues. 2	Can all the presentations be sent electronically to all the Town Clerks?	Copies of the presentations were emailed to all Town and Parish Clerks shortly after the conference and are available on the Council's website. Peter Fraser
3	What is this "panel of local representatives"?	The Sustainable Communities Act 2007 requires local authorities to consult and reach agreement with local people via a "panel of representatives" before submitting proposals to central Government. The legislation and guidance says only that they must be made up of 'representatives of local persons'. This is defined as 'a balanced selection of the individuals, groups or organisations the authority considers likely to be affected by, or have an interest in the proposal'. In this context, the term 'representative' does not refer to formally elected or nominated members of the community such as councillors or officeholders in community organisations (although such individuals are not excluded from taking part in panels). 4	What are citizen panels and how can we use them?	A citizen, or resident, panel is a group of people who are broadly representative of the population in terms of where they live and characteristics such as age, gender and ethnicity. Central Bedfordshire Council jointly runs a large panel with Bedfordshire and Luton Fire and Rescue Service and Bedfordshire Police Authority called BedsVoice, consisting of 5,000 residents across Bedfordshire (excluding Luton). All of the panel members have agreed they are willing to be consulted about local issues. If a Town or Parish Council wanted to use the panel they would need to contact the relevant panel members (through Central Bedfordshire Council) to ask them if they would be happy to take part in the Town and Parish Council consultation. This is required to satisfy the data protection requirements. There would be a charge to the Town and Parish Council for this initial correspondence. Peter Fraser
5	Will you please pass the views of Town and Parish Councils back to Central government instead of just towing the line that is fed to you by them?	Central Bedfordshire Council officers and Members regularly meet with senior colleagues from regional government (via GO-East) and Whitehall departments, and take every opportunity to feedback views from the area. Peter Fraser
6	Will Parish Forums return and if so will there be funding and admin support?	The Council is committed to delivering a robust approach to Community Engagement - ensuring collaborative working that maximises the quality of services and opportunities for the residents of Central Bedfordshire. Our work to date has identified very mixed views on the need / benefit of area based forums. Whilst there are no plans to implement specific parish forums, we are committed to supporting area based work where the uniting of parishes will accelerate the resolution of common community-based problems. 13	Far too much jargon in this police report – what does "improved resilience across area response" mean?	Apologies for use of jargon. What I mean is that the structural changes that have taken place have enabled me to pull in additional resources / officers. 14	The Shefford Snt is 30% under strength, according to Sgt Denham. This has allowed crime figures to rocket. How/when do you intend to rectify the man power problem in the Shefford Snt? Paul Makin, Shefford Town Mayor	The SNT at Shefford consists of a NPO (Constable) and two PCSOs. There are no vacancies either within this team or the wider Ampthill SNT. In fact we have just created two additional posts within the wider team (former Mid-Beds area) and posted two Sergeants to these positions.
		There are a number of officers within the SNT who, through injury are on restricted duties. They are being managed to ensure a speedy recovery and return to full duties. They are supporting front line officers in other ways.
		I would also like to reassure the Mayor that both crime and incidence of antisocial behaviour (ASB) within the Shefford area has actually fallen.
		In the three month period Nov 08 to Jan there were 73 recorded crimes within Shefford in the next three month period Feb 09 to April 09 there were 56 recorded crimes, a reduction of 23%.
		The latest crime figures indicate that in April and May this year there were 32 recorded crimes and 7 incidents of ASB, in the same period last year there were 43 crimes and 21 incidents of ASB. I.e. a 45% and 33% reduction. Neil Wilson, Bedfordshire Police
15	Policing in rural areas is no working it needs more proactive approach and more visability in the village. Totternhoe Parish Council	The Neighbourhood Police Officer PC Dady is working closely with partners and the Parish Council. She attends as many Parish Council meetings as she can. However, she has another 6 villages to share her time with.
		In order to improve visibility and increase the number of foot and bike patrols within the locality a dedicated PCSO for the Totternhoe / Eaton Bray neighbourhood was appointed on 19th March 2009. Neil Wilson, Bedfordshire Police

16	We used to have, and pay for our own, PCSO. Now we can't do this, and instead we have to share one with other Parishes and now we are being criticised about lack of visible police presence. How can we get our PCSO back?	The funding arrangements with the Home Office allowed the Police to seek partnership funding with the Town & Parish Councils whereby for £6,000 a full time PCSO was provided with the Police paying the other £18,000. This was a temporary arrangement managed through the contracts that expired and caused a significant operational imbalance in the deployment of PCSOs across Bedfordshire and Luton. There could be an opportunity for the Town to purchase additional PCSO or Police Officer time but would be on a full costs recovery basis. This could be explored if the Town and or neighbouring villages wished to explore it. Neil Wilson, Bedfordshire Police
17	Have the police been able to recruit more PCSO staff to increase the presence in villages?	The establishment of PCSOs in the county is 128. We have recruited up to this level and further recruitment is taking place to maintain these resource levels. This level is the fully budgeted establishment. Neil Wilson, Bedfordshire Police
18	Police/ Magistrates – Can we please slow down the recycling time of criminals through prison.	A Subject close to my heart, although not one I can influence in any way. The police have no influence whatsoever in sentencing; it is a matter for the Courts. The issue is therefor one for the wider Criminal Justice System and in particular the Courts. The local Criminal Justice Board can and do feedback to the Home Office and Ministry of Justice via the Office of Criminal Justice Reform, the concerns of our local communities in such matters. 19	Petition the police to reconsider their command decision re-response from Leighton Buzzard Police Station instead of Dunstable. Has rural Policing failed? Kensworth Parish Council	Chief Inspector Waring is reviewing the response function and Neighbourhood Policing Model within the South Bedfordshire area. In particular the best way to ensure an efficient response to incidents occurring within Paddington and the other villages south of Dunstable. I would like to reassure these villages that while Leighton Buzzard maybe used as an administrative centre, the most appropriate unit will respond. This also includes other police resources such as Roads Policing and other Operational Units such as Armed and Dog resources in emergencies. Neil Wilson, Bedfordshire Police

20	Police – will the main call centre remain in kempston? Police call out times evenings/ weekends/ Bank holidays so poor, will this improve? Kensworth Parish Council	Yes. There are no plans to relocate the Call Centre from Kempston. Response to incidents is dealt with according to the type of incident and how it is graded. There should be no degradation at the weekends. However there may be a perception of this and comments will be fed back to the Call Handlers to ensure understanding of expectations. Lower graded incidents are responded to differently than emergencies and more serious issues. Neil Wilson, Bedfordshire Police
21	Police – PROVE the claimed improvements be seen to be strong in handling complaints.	Not sure what the questioner is asking. Improvement in performance against reduction and detection targets has been well documented. I can give more detail if required. In regards to police complaints there has been a national change in the way complaints are handled (Taylor Report). There is now much more emphasis on handling complaints locally with managers taking responsibility to seek speedy and local resolution. The independent monitoring and audit of how we handle such issues is through the Professional Standards Committee of the Police Authority and the Independent Police Complaints Commission (IPCC). Planning/ Growth/ Housing

Will the new authority provide what we really want? Sustainable housing for natural growth and all the infrastructure that goes with it. Not the huge unsustainable housing defined in the core strategy. One of the objectives of the Government's "Sustainable Communities Plan" published in 2003 is to provide sustainable growth which will be of benefit to both our existing and future communities alike. Whilst the housing and employment targets set out within the Milton Keynes and South Midlands Sub-Regional Strategy (MKSMSRS) are challenging, we see the growth area objectives as an opportunity to reinforce and improve the places we live and work by improving public transport network, access to the countryside and our town centres.

For the Luton and Southern Bedfordshire area, in order for strategic urban extensions to be truly sustainable, they will be required to deliver a critical mass (in housing and employment terms) that will enable them to function in a way that does not place unreasonable burdens on existing or new infrastructure. They should also contribute to serving the needs of adjacent existing urban areas where infrastructure deficits exist. This approach of bringing forward a small number of large-scale mixed use urban extensions is considered more preferable, in the context of Luton and Southern Bedfordshire, to bringing forward a larger number of smaller nonstrategic ones that will be unlikely to bring forward appropriate amounts of supporting infrastructure. For example, we consider that such strategic urban extensions should provide no less than 2,500 dwellings of mixed tenure and between 15-20ha of employment land.

What if you don't find the employment to match the 60,000 houses? Do you not build them or do you have to build them regardless?

I would imagine that the vast majority of parish councillors feel that the biggest issue is the affect of the growth plan. This conference did not address this directly it only talked in general terms about managing the growth. The fact is most parishes want to scale down the growth to truly manageable and sustainable levels. In order to create truly sustainable communities, housing cannot happen in isolation from employment and service provision. Our research and consultation with stakeholders has identified the preferred locations for employment land and we will endeavour to deliver these through the Local Development Framework process. Our economic regeneration team will be working closely with key stakeholders in order to promote these employment sites. Notwithstanding the current economic slow down, Regional and Sub-Regional policy expects that the employment targets for the period - 2031 will be met.

The growth area agenda represents a step change in the delivery of housing and employment provision. The housing and employment targets are rigid and have been set at Sub-Regional level. In order to meet the Government's "Sustainable Communities Plan", there is an expectation that these targets, which are expressed as a minimum, are to be met and the onus is on the authority to do so. Whilst we recognise the concerns of the parishes in relation to the Luton and Southern Bedfordshire Core Strategy, it remains part of the Joint Committee's vision that where practical, the identity of rural villages will be safeguarded. As set out at point i), our preference for the Luton and Southern Bedfordshire area is to deliver growth by bringing forward a small number of large-scale mixed use urban extensions as opposed to a larger number of smaller non-strategic ones. What are Central Beds policies for giving parish councils more say about housing and roads in rural areas. Luton and Dunstable urban muscle have dominated the scene, especially the core strategy.

As set out in our Statement of Community Involvement (SCI), we recognise and appreciate the importance of community involvement in the plan making process. The former south Bedfordshire area is currently undergoing a public consultation exercise that seeks the views of the community in respect of the Core Strategy Preferred Options. This has involved 7 manned exhibition venues across the former authority area together with a dedicated website and questionnaire opportunity. The Milton Keynes South Midlands Sub-Regional Strategy is clear that the main focus of urban growth should be directed toward Dunstable and Houghton Regis in order to help regenerate those towns. Therefore, the large infrastructure requirements would by definition have to be directed toward servicing both the exiting and future populations thereabouts. Notwithstanding this however, the larger villages at least will be expected to take additional development and the views of those parish councils will be actively sought in how to shape the proposed development that may be directed there. Small scale reviews of the Green Belt boundary around these settlements may be required. Both this matter and the allocation of land to satisfy the need for development in the rural area will be brought forward through the Site Allocations Development Plan Document which will follow and accompany the Core Strategy within the Local Development Framework. Where committees have a village design statement document in place and adopted by former mid beds planning as a consultation document – can you confirm if this will continue to be the case? Lot of community involvement and support for this and extremely disappointed if as a body they are disregarded. We recognise and value the importance of village plans in their evidencing of community led consultation and localised identification of needs, wants and aspirations.

We are currently undertaking a review on how we support the creation and delivery of Parish Plans to better deal with how the Council responds to their existence. The whole spectrum of issues/services for which the Council has responsibility for is addressed within PPs; not the physical planning issues alone. Because of this, our position is that it is not deemed reasonable for the Council to 'adopt' or 'endorse' the plans per se, rather that we become specific with our responses on Planning issues (and all service issues) during their development stage.

We anticipate that this will offer an early and collaborative input clearly indicating what we are able to be proactive on with our support. It also emphasises that 'ownership' of the plans along with initiating activity delivery starts at source.

Consideration is being given to how we 'formally receive' PPs to help inform and raise opportunities for joint working as appropriate across the council. We will also approach the LSP to undertake a similar process for receiving them though this is at a very early stage.

The change to unitary status has not therefore affected the status of these plans within the planning system. We will be writing to Town and Parish Councils in the coming months in relation to village plans and the two emerging LDFs for Central Bedfordshire and will have regular contact opportunities to maintain a dialogue through 6 monthly (TBC) Town and Parish Forum meetings. Given the present status of the emerging LDF's for Central Bedfordshire, we would wish to take this opportunity to review those existing Village Design Statements. Mark Saccoccio

27	Why can't local parish councils be involved in the formality and setting up of section 106 agreements. At the moment we get told what is in their offer they have been signed and then we are left with the mess!	The majority of Agreements are now sought using the Planning Obligations Strategy. This is not an 'offer' but is a requirement identified by the needs assessment undertaken as part of the creation of this document. The use of Section 106 Agreements are controlled by statute and guidance on them are contained in Government produced Circulars. The legal content is vetted by the Council's legal team to ensure that the obligations set out in the Agreement are subsequently able to be secured. All negotiations relating to Agreements have to be undertaken in accordance with the guidelines set out in the Circulars. Gary Worth

Website - some bits not work e.g. currently council tax below

No 0800 numbers

Clerks need up to date list of key officers (direct lines)

Customer service - transferring around several staff

Very poor phone system now

Being passed from pillar to post

Been ignored in past or no feedback – need clear explanations

Not always getting response to emails

Highways helpdesk not up to date

Accessible customer services / no hand off

Officers direct lines being diverted to customer services - better to go to voicemail

Letter acknowledgement and email

Parish Council complaints don't get response as a priority

Lack of response from some officers

Particularly difficult getting responses from enforcement team

Responses back to some T/P C enquiries – takes too long, sometimes not answered, service standard would help, at least an up date

Would like CB Cllr to come to T/P C meetings and take issues back

Timing of meetings often on same night - better arrangements to avoid no attendance

Poor S.106 consultation with Parish Councils

Lip service – consultant – especially in planning

Not always getting copies of planning decisions

Engage at issues stage

Get rid of 3 minute rule to speak at planning meetings

Planning a problem – advice ignored, feedback needed as to why decisions changed

No sufficient explanation of the reasons for decision (e.g. decision on allotment never understood – why?). Planning decision audit trail must be there in future generations.

LSP thematic groups

Officer titles don't mean anything meaningful

How to keep up to speed with emerging local issues e.g. licensing charges

Big change LGR – must communicate clearly and quickly. Depends on quality of the communication.

CANs - not well put over at Whipsnade and documentation

Should they be aspirational or regulatory?

Come back to parishes and say what is achievable

Worthwhile – but is it aspirational e.g. HGV strategy – not in gift of parish

Grass cutting, litter picking, street cleaning – easier to arrange locally, could work with neighbouring towns/ parishes

Grass cutting and associated allowances

Grass cutting, grounds/ street cleansing – (possible large town councils)

Grass cutting (but note economies of scale & money), road sweeping & street cleaning, weed killing, no facilities for young people – bus/ provide a way to help young people to get out once every week.

Local policing (PCSOs)

Verge cutting/ highways

Weed control

Weed spraying

Weed spraying – alleyways, footpaths

Roads, drains, highways, footpaths, hedgerows

Planning decisions, street cleaning, minor street maintenance

Road repairs, litter picking, odd jobs, sign maintenance, reporting problems

Uses of offenders re community risks

Ampthill – grass cutting, weed killing, salting pavements

Leighton – theatre and market

Sandy – street sweeping, maintaining footpaths

Stotfold - street sweeping, footpath maintenance, grass cutting and weed killing

Issue - equity of service between former MBDC and SBDC areas

Play areas - mixed responsibility

Cranfield, Langford & Potton - Hedge cutting, weed spraying,

Delegate functions best done by towns e.g. town centre management, car parking, grass cutting, some transport & highways functions etc.

Significant issues – no funding or resources

Resources - people / £ dependent (by individual council)

Non-ring fenced partnership money

No devolved services without money as well up front

Funding - often one year at a time, one off experience of CC fund mixed

Depends on available funding and resources

Funds allocated to parishes – why are we told what to spend it on – CBC might as well do it!

More flexibility on limited funding for PCs to manage

Realising the lack of cost efficiency but seeing "value from money spent"

Have to precept for them

Don't want to put parish precept up

Experience hasn't given benefit on devolution e.g. market management

Difficult for small parishes

Depends on size of parish – capacity issues a significant obstacle, councils should not be penalised if they are unable to take on devolved services

Remember Cllrs are volunteers, depends on size, funding needs to come with it, not "services on the cheap"

Very different capacity across the sector

Quality status less relevant for small parishes

Would training go with devolved responsibility?

Skill more than one contact

Skills, experience to explore this - support could help

Still co-opted parish Cllrs – not elected

Devolution – needs a lot more scrutiny – what do you mean?

Devolved services - determine local priorities

Chamber of commerce to help create jobs (in partnership)

Section 106 monies / processes – too restrictive/ not enough consultation with T&P Councils during agreement creation

Q7. What other support can CBC provide to help Town and Parish Councils carry out their community roles more effectively?

Recruitment of clerks – possibly a pool of clerks
Induction training for new T/P Councillors (when they are new)
Responsibilities of T&P Council Cllrs – including code of conduct
