CENTRAL BEDFORDSHIRE COUNCIL (DEFINITIVE MAP AND STATEMENT FOR  
BEDFORDSHIRE) (CLOPHILL: FOOTPATH NOS 10 AND 11) MODIFICATION ORDER 2010

The above Order made on 12 March 2010, if confirmed as made will modify the definitive map and statement for the area by adding to them the two footpaths described below.

Footpath No 10 Clophill to be added extends from its junction with the High Street at Ordnance Survey Grid Reference (OS GR) TL 0926 3822 along Old Church Path in a north north westerly and then northerly direction for approx 228 metres to its junction with Footpath No A2 Clophill at OS GR TL 0920 3843 where the path terminates.

The footpath has a variable width of between 3.2 metres and 3.8 metres as delineated by the faces of the buildings and walls or fences or base of the bank on the west side of Old Church Path and the base of the bank on the east side of Old Church Path.

Footpath No 11 Clophill to be added extends from its junction with Great Lane and Footpath No 5 Clophill at OS GR TL 0896 3873 in a generally south easterly direction for approx 215 metres to its junction with Footpath No A2 and Old Church Path at OS GR TL 0915 3865 where it terminates.

The footpath has a width of 2.5 metres

A copy of the Order and the map may be seen free of charge at the offices of Countryside Access Service, Central Bedfordshire Council, Borough Hall, Bedford between 9.00am and 5.00pm on Mondays to Thursdays and between 9.00am and 4.00pm on Fridays. Copies of the Order and the Order map may be purchased. An explanatory statement can be obtained by phoning 0300 300 6249.

Any representation or objection relating to the Order must be sent in writing to the Orders & Commons Registration Officer, Countryside Access Service, Central Bedfordshire Council, PO Box 1395, Bedford MK42 5AN not later than 7 May 2010, and applicants are requested to state the grounds on which it is made.

If no representations or objections are duly made to the Order, or to any part of it, or if any so made are withdrawn, Central Bedfordshire Council may, instead of submitting the Order to the Secretary of State for the Environment, Food and Rural Affairs, itself confirm the Order. If the Order is submitted to the Secretary of State in whole or in part, any representations or objections which have been duly made and not withdrawn will be sent with it.
