NOTICE OF MAKING OF PUBLIC PATH ORDER
TOWN AND COUNTRY PLANNING ACT 1990

CENTRAL BEDFORDSHIRE COUNCIL (PART OF CRANFIELD FOOTPATH NO 23) PUBLIC PATH
DIVERSION ORDER 2018

The above Order made on 21 May 2018 under Section 257 of the Town and Country Planning Act 1990 if confirmed will divert part of Footpath No. 23, Cranfield as shown on the Order map.

The length of Footpath No 23, Cranfield to be diverted extends from Ordnance Survey Grid Reference (OS GR) SP 9423 4317 (Order map – point A) in a west north westerly direction for approximately 100 metres to OS GR SP 9413 4320 (Order map – point B).

The alternative highway to be provided and known as Footpath No 23, Cranfield extends from OS GR SP 9423 4317 (Order map – point A) in a generally west south westerly direction for approximately 46 metres to OS GR SP 9419 4316 (Order map – point C) then continues in a generally west south west then north and then west north westerly direction for approximately 73 metres to OS GR SP 9413 4318 (Order map – point D) then continues in a generally northwards direction for approximately 17 metres along an existing grassed track to OS GR SP 9413 4320 (Order map – point B).

The new length of footpath has a width of 2 metres

Under section 257 of The Town and Country Planning Act 1990 “a competent authority may by order authorise the stopping up or diversion of any footpath, bridleway or restricted byway if they are satisfied that it is necessary to do so in order to enable development to be carried out”.

The land over which this part of Footpath No. 23, Cranfield passes has been granted planning permission to build a clean pilot hall and welfare facility, adjacent to the existing sewage treatment works pilot hall. (CB/17/03375/MW). The Public Footpath would be obstructed by the development unless it is diverted to a new line. Central Bedfordshire Council consider it necessary to divert the footpath in order to allow the development to take place.

A copy of the Order and the Order map have been placed and may be seen free of charge at the offices of Central Bedfordshire Council Highways, Priory House, Monks Walk, Chicksands, Shefford SG17 5TQ between 9.00am and 5.00pm on Mondays to Thursdays and between 9.00am to 4.00pm on Fridays. Copies of the Order and map may be bought there at a charge of £4.00. An explanatory statement can be obtained by phoning 0300 300 6350.

Any representations or objections relating to the Order must be sent in writing to the Senior LSG Officer, Central Bedfordshire Council, Highways, Priory House, Monks Walk, Chicksands, Shefford SG17 5TQ not later than 29 June 2018. Please state the grounds on which they are made. Representations and objections must include either a postal or e-mail address. Any representations or objections made will be in the public domain and will be available for viewing/copying by members of the public.

If no such representations or objections are duly made, or if any so made are withdrawn, Central Bedfordshire Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the Order and will be made publicly available by either the Council or the Planning Inspectorate.
