#### What to expect at your assessment

You have asked us to help you with housing. We need to fully assess your circumstances so that we can work with you to get the best outcome for you and your household. An appointment has been made for you to meet with a Housing Options Advisor to do this.

- You will need to bring some documents with you to your appointment and these are listed below
- Our aim is to provide you with a plan, based on your personal circumstances, to prevent you from becoming homeless.
- The plan will provide you with steps that you need to take and steps that the Council can take to support you to stay in your current home or, if that is not possible, to find a new home which will be available to you for at least six months.
- You are welcome to bring a friend or advisor with you to the assessment. You can request for your Housing Advisor to be of the same sex.
- If you have already become homeless, whether or not you have been provided with temporary accommodation, the assessment will take into account the steps that you need to take and the steps that the Council can take to relieve your homelessness so that you can find suitable accommodation to move to.
