Notice of Confirmation of Public Path Order
Highways Act 1980

CENTRAL BEDFORDSHIRE COUNCIL (GRAVENHURST: PART OF FOOTPATH NO 4) PUBLIC PATH DIVERSION ORDER 2018

On the 6 July 2018 Central Bedfordshire Council confirmed the above Order made under Section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to divert the following length of public Footpath No 4, Gravenhurst, as shown on the Order map.

The length of Footpath No 4, Gravenhurst to be stopped up extends from its junction with another part of Footpath No 4, Gravenhurst at Ordnance Survey Grid Reference (OS GR) TL 1131 3602 (Order Map - point A) in a north easterly direction for approximately 114 metres to a point to the rear of No 69 High Street at OS GR TL 1140 3609 (Order Map - point C) where it has a junction with another part of Footpath No 4, Gravenhurst.

The length of Footpath No 4, Gravenhurst to be created extends from its junction with another part of Footpath No 4, Gravenhurst at Ordnance Survey Grid Reference (OS GR) TL 1131 3602 (Order Map - point A) in a north easterly direction for approximately 27 metres to its junction with another part of Footpath No 4, Gravenhurst at OS GR TL 1133 3604 (Order Map - point D) then continues in a generally north easterly direction for approximately 74 metres to OS GR TL 1138 3609 and then extends in a generally east north easterly direction for approximately 14 metres to OS GR TL 1140 3609 (Order Map - point C) where it has a junction with another part of Footpath No 4, Gravenhurst.

The new route of the footpath has a width of 1.75 metres at Ordnance Survey Grid Reference (OS GR) TL 1131 3602 (Order Map - point A) decreasing to 1.3 metres at OS GR TL 1133 3604 (Order Map - point D) with a pinch point of 1.25 metres at the telegraph pole at OS GR TL 1132 3603. The footpath has a width of 2.0 metres between OS GR TL 1133 3604 (Order Map - point D) and OS GR TL 1140 3609 (Order Map - point C).

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at the offices of Central Bedfordshire Council Highways, Priory House, Monks Walk, Chicksands, Shefford SG17 5QT between 9.00am and 5.00pm Mondays to Thursdays and between 9.00am to 4.00pm Fridays. Copies of the Order and map may be bought there at a charge of £4.00.

The Order comes into force on 13 July 2018, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the grounds that it is not within the powers of the Highways Act 1980, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 12 July 2018 make an application to the High Court.
