Definitive Map and Statement for Central Bedfordshire as at 10 October 2014

CENTRAL BEDFORDSHIRE COUNCIL (DEFINITIVE MAP AND STATEMENT FOR CENTRAL BEDFORDSHIRE) (HOUGHTON REGIS: BRIDLEWAY NO. 12) MODIFICATION ORDER 2015

The above Order made on 8 May 2015, if confirmed as made will modify the definitive map and statement for the area by:-

Deleting Bridleway No 12, Houghton Regis as marked by a bold black solid line on the Map and extends from its junction with the A5120 Bedford Road at Ordnance Survey Grid Reference (OS GR) TL 0135 2449 (Map point J) in a generally west-south-westwards direction for approximately 154 metres along the northern edge of a paddock to a stream at OSGR TL 0121 2445 and then continues in a generally westwards direction for approximately 90 metres through a spinney to cross a concrete track at OSGR TL 0112 2446 and then continues in a generally westwards direction for approximately 50 metres across an arable field to terminate at its junction with Footpath No 4, Houghton Regis at OSGR TL0107 2447 (Map point K).

A copy of the Order and the map may be seen free of charge at the offices of Countryside Access Team, Central Bedfordshire Council, Priory House, Monks Walk, Chicksands, Shefford between 9.00am and 5.00pm on Mondays to Thursdays and between 9.00am and 4.00pm on Fridays. Any representation or objection relating to the Order must be sent in writing to the Definitive Map Officer, Countryside Access Team, Central Bedfordshire Council, Priory House, Monks Walk, Chicksands, Shefford, SG17 5QT not later than 3 July 2015, and applicants are requested to state the grounds on which it is made. Representations and objections must include either a postal or e-mail address. **Any representations or objections made will be in the public domain and will be available for viewing/copying by members of the public.**

If no such representations or objections are duly made, or if any so made are withdrawn the Central Bedfordshire Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the Order and will be made publicly available by either the Council or the Planning Inspectorate.
