1. Introduction

The Chairman informed this meeting was solely to consider one funding application.

2. Apologies for Absence

Central Bedfordshire Council Cllr Gill Clarke Shefford Parish Council Cllr P.Machin

3. Update on previous applications:-

The Chairman provided an update on the status of applications previously determined by the committee

- The clerk of Northill Parish Council has requested a short extension of time to invoice for the noticeboards (grant approved May 2014) due to weather delaying installation. Currently the grant is required to be claimed by 1st December 2014. Cllr Keith Bennett reported the noticeboards had been installed that day. The group agreed that the parish council could submit their invoiced during December.
- Susan Marsh reported Langford Methodist Church and Caldecote Cricket Club had invoiced the Council for grant money. This was for, respectively, replacement windows and equipment for the upkeep of the cricket field. Photos were circulated.

 An updated balance sheet of spending to date and remaining funds available had been previously circulated to members & available.

4. The application to be considered at this meeting:-

A funding application was considered by the committee in respect of a request made by:

a) All Saints Church, Upper Caldecote

Father Frank and Churchwarden Mrs Joy Goddard, gave a short presentation on behalf of All Saints Church and then took questions. They left the meeting prior to the vote.

Father Frank and Mrs Goddard made the following comments:

- Local community. groups & primary school made good use of the church building.
- the building was approximately 150 years old
- The damp endangers the future of the church building.
- There is no funding available from the diocese
- Two other charities have been approached but not had meetings yet to see if successful
- They would some Church savings towards ongoing repairs and restoration works, but there is not enough - once the damp repairs had been completed, the church needs rewiring.
- The investigative works start after Christmas and, if funding was available, the works would start soon after so that and completed by the summer.

Following a discussion there was some uncertainty as to the exact nature and cost of the works required as these would not be identified until the investigative works had been carried out after Christmas, so the Chairman proposed;

- To could contribute the full amount requested by the applicant (£8000) subject to the grant paid not exceeding 50% of the overall costs of the repairs excluding fees and VAT.
- This was carried by a vote (3 in favour, 0 against (no one present to vote for Shefford)).
