(CONSOLIDATION) ORDER 2008) (VARIATION NO.53) ORDER 2017

The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 10th day of April 2017 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.53) Order 2017"
2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To add No Waiting at any time on the following lengths of road in Flitwick:-

- (i) High Street, west side, from a point approximately 4 metres south of the boundary of nos. 1b and 3 High Street extending in a southerly direction for approximately 39 metres.
- (ii) High Street, east side, from a point in line with the south flank wall of no.24 High Street extending in a southerly direction for approximately 38 metres.
- (iii) Pilgrims Close, north side, from its junction with High Street extending in an easterly direction to a point approximately 4 metres east of the boundary of nos. 1 and 2 Pilgrims Close.
- (iv) Pilgrims Close, south side, from its junction with High Street extending in an easterly direction to a point in line with the boundary of nos. 1 and 2 Pilgrims Close.
- (v) Ampthill Road, east side, from a point approximately 2 metres north of the boundary of nos. 46 and 48 Ampthill Road extending in a southerly direction to a point approximately 5 metres north of the boundary of nos. 40 and 42 Ampthill Road.
- (vi) Admiral Row, both sides, from its junction with Ampthill Road extending in an easterly direction to a point in line with the rear wall of no. 46 Ampthill Road.

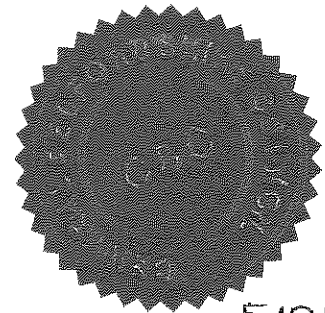
To add No Waiting at any time on the following lengths of road in Cranfield:-

- (i) High Street, south-east side, from a point approximately 1 metre north-east of the boundary of nos. 144a and 146 High Street extending in a south-westerly direction to a point in line with the boundary of nos. 142a and 142b High Street.
- (ii) Red Lion Close, north side, from its junction with High Street extending in a south-easterly direction to a point approximately 3 metres north-west of the boundary of nos. 1 and 3 Red Lion Close.
- (iii) Red Lion Close, south side, from its junction with High Street extending in a south-easterly direction to a point in line with the boundary of no. 142b High Street and no. 2 Red Lion Close.

- (iv) High Street, south side, from a point approximately 1 metres west of the east flank wall of no.188 High Street extending in an easterly direction to a point in line with the boundary of nos.192 and 194 High Street.
- (v) Bakery Close, both sides, from its junction with High Street extending in a southerly direction to a point in line with the front wall of no.190b High Street.
- (vi) High Street, south-east side, from a point approximately 5 metres north-east of the boundary of nos.52 and 54 High Street extending in a north-easterly direction to a point approximately 6 metres south-west of the boundary of nos.66 and 68 High Street.
- (vii) Rowan Way, both sides, from its junction with High Street extending in a south-easterly direction to a point approximately 3 metres south-east of the front wall of no.68 High Street.
