

# Small Business Rates Relief

2018/2019

The tables below show the Business Rates payable from April 2018 by businesses able to claim Small Business Rates Relief (SBRR), who occupy a single property having a Rateable Value between £12,000 and £15,000 for the financial year 2018/2019, and the percentage relief this is equivalent to.

They are based on the Small Business non-domestic multiplier for 2018/2019 which has been set by Central Government at 48p in the pound.

**Since 1 April 2017, businesses occupying only one property with a rateable value below £12,000 should be paying NO rates.**
