Notice of Making of Public Path Order
Highways Act 1980

CENTRAL BEDFORDSHIRE COUNCIL (TODDINGTON: PART OF BRIDLEWAY NO 58) PUBLIC PATH CREATION ORDER 2019

The above Order made on 1 February 2019 under Section 26 of the Highways Act 1980 will create Bridleway No 58, Toddington as shown on the Order map.

That length of Bridleway No. 58, Toddington to be created extends from its junction with Kimberwell Close at Ordnance Survey Grid Reference (OS GR) TL 0095 2797 (Order map - point E) in a south easterly direction for approximately 76 metres along an alleyway and then over a grassed area to OS GR TL 0100 2791 (Order map – point F) then extends in a generally east north easterly direction for approximately 19 metres on the northern side of an historic field boundary to OS GR TL 0102 2792 (Order map – point C) then extends in a south south easterly direction on the eastern side of a field boundary at a distance of 2 metres from the root of the hedge for approximately 82 metres and then at a distance of 3 metres for the root of the hedge for approximately 26 metres to OS GR TL 0107 2782 (Order map – point G) and then continues in an east north easterly direction for approximately 25 metres at a distance of approximately 7.0 metres and then 5.0 metres from the face of the wall to terminate at its junction with another part of Bridleway No. 58, Toddington at OS GR TL 0109 2784 (Order map – point D).

The new length of bridleway has a width of 4 metres between OS GR TL 0095 2797 (Order map - point E) and OS GR TL 0100 2791 (Order map – point F) and also between OS GR TL 0102 2792 (Order map – point C) and OS GR TL 0109 2784 (Order map – point D).

The new length of bridleway has a width of 3 metres between OS GR TL 0100 2791 (Order map – point F) and OS GR TL 0102 2792 (Order map – point C).

Limitations and Conditions: A head room restriction caused by a low tree limb at OS GR TL 0101 2791.

A copy of the Order and the Order map have been placed and may be seen free of charge at the offices of Central Bedfordshire Council Highways, Priory House, Monks Walk, Chicksands, Shefford between 9.00am and 5.00pm on Mondays to Thursdays and between 9.00am to 4.00pm on Fridays. Please state the grounds on which they are made. Representations and objections must include either a postal or e-mail address. Any representations or objections made will be in the public domain and will be available for viewing/copying by members of the public.

If no such representations or objections are duly made, or if any so made are withdrawn the Central Bedfordshire Council may confirm the Order as an unopposed Order. If the Order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the Order and will be made publicly available by either the Council or the Planning Inspectorate.
