The Central Bedfordshire Council (the "Council") in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 15th day of October 2010 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008 (Variation No 10) Order 2010"
  
2. As from the date upon which this Order comes into operation, the provisions of the "Central Bedfordshire Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
  - (i) The plan schedule reference "Area Code W111 Sheet: Number 1" shall be deleted and "Area Code W111: Sheet Number 2" shall be substituted.
  - (ii) The plan schedule reference "Area Code W110 Sheet: Number 1" shall be added to the plans attached to the Order.

On the 8th October 2010 Central Bedfordshire Council made a Traffic Regulation Order as follows:

Effect of the Order:

**To introduce No Stopping from 8am to 4:30pm Monday to Friday inclusive on the school entrance markings on the following lengths of road in Toddington:-**

1. Manor Road, Toddington: North east side from the boundary between property No.67 Manor Road and St George Lower School in a south easterly direction for approx 44 metres.
2. Park Road, Toddington: South west side from the south eastern boundary of property No 9 Park Road in a south easterly direction for approx 44 metres.

Date of Operation: The Order will come into operation on the 15th October 2010.

Further Details of the Order and a plan showing the lengths of road affected may be examined during normal opening hours at Toddington Library, 9 Market Square, Toddington.

High Court Challenge: Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 14th October 2010 make application for the purpose to the High Court.
