The Central Bedfordshire Council (the "Council") in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 20th day of December 2010 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No 11) Order 2010"
  
2. As from the date upon which this order comes into operation, the provisions of the "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
  - (i) The plan schedule reference "Area Code F127: Sheet Revision Number – 1" shall be deleted and "Area Code F127: Sheet Revision Number -2" shall be substituted.
  
  - (ii) The plan schedule reference "Area Code Y130: Sheet Revision Number – 1 shall be deleted and "Area Code Y130: Sheet Revision Number – 2" shall be substituted

Effect of the Order:

**To introduce No Waiting at Any Time (double yellow lines) on the following length of road in Leighton Buzzard:-**

- Lake Street, Leighton Buzzard: north-east side from a point 4 metres northwest of the south east flank wall of the Public Library for a distance of approx 3 metres.

Note:-The existing parking space that is limited to 30 minutes (no return within 2 hours) from 8am to 6pm Monday to Saturday that is currently in place on the above length of road will be removed.

Date of Operation: The Order will come into operation on the 20th December 2010.

Further Details of the Order and a plan showing the lengths of road affected may be examined normal opening hours at Leighton Buzzard Library, Lake Street, Leighton Buzzard, LU7 1RX.

High Court Challenge: Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 16th December 2010 make application for the purpose to the High Court.

**To introduce No Waiting at Any Time (double yellow lines) on the following length of road:-**

Bidwell Hill, Houghton Regis which extends from a point 25.5 metres east of the rear boundary wall between Nos 6 and 8 St. Michaels Avenue in a north east direction for a distance of approx 16.5 metres, to join the existing no waiting at any time restrictions in Bedford Road.

Date of Operation: The Order will come into operation on the 20th December 2010.
