The Central Bedfordshire Council (the "Council") in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

- This Order shall come into operation on 28th day of February 2011 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No 12) Order 2011"
- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
 - (i) The plan schedule reference "Area Code AB133: Sheet Revision Number 1" shall be deleted from the plans attached to the Order and "Area Code AB133: Sheet Revision Number 2" shall be substituted.
 - (ii) The plan schedule reference "Area Code AB134: Sheet Revision Number 1" shall be deleted from the plans attached to the Order and "Area Code AB134: Sheet Revision Number 2" shall be substituted.
 - (iii) The plan schedule reference "Area Code AA135: Sheet Revision Number 1" shall be deleted from the plans attached to the Order and "Area Code AA135: Sheet Revision Number 2" shall be substituted.
 - (iv) The plan schedule reference "Area Code AB135: Sheet Revision Number 1" shall be deleted from the plans attached to the Order and "Area Code AB135: Sheet Revision Number 2" shall be substituted.

On the 21st February 20110 Central Bedfordshire Council made a Road Traffic Regulation Order as follows:

Effect of the Order:

To introduce No Waiting At Any Time on the following lengths of road in Dunstable:

A. Northern corner of Humphrys Road

- 1. Humphrys Road, north-west and north-east sides, from a point approximately 17 metres southwest of the north-east flank wall of no.16 Humphrys Road in a north-easterly, then southeasterly direction for a distance of approximately 126 metres.
- 2. Humphrys Road, south-east and south-west sides, from a point approximately 17 metres south-west of the north-west flank wall of no.16 Humphrys Road in a north-easterly, then south-easterly direction for a distance of approximately 86 metres.

B. Southern corner of Humphrys Road

- 1. Humphrys Road, south-west side, from a point approximately 8 metres south-east of the north-west flank wall of no.11 Humphrys Road in a south-easterly direction for a distance of approximately 40 metres.
- 2. Humphrys Road, south side, from the south-eastern end of the access road to the rear of nos.1 to 3 Humphrys Road in a generally easterly direction for a distance of approximately 43 metres.
- 3. Humphrys Road, north-east and north-west sides, from a point approximately 8 metres south-east of the north-west flank wall of no.11 Humphrys Road in a south-easterly, then north-easterly direction for a distance of approximately 104 metres.

C. Eastern corner of Humphrys Road

1. Humphrys Road, both sides, from a point approximately 30 metres south-east of the projection of the north-western flank wall of no.7 Humphrys Road in a southerly, then south-westerly direction for a distance of approximately 102 metres.

<u>Date of Operation:</u> The Order will come into operation on the 28th February 2011.

<u>Further Details</u> of the Order and a plan showing the lengths of road affected may be examined during normal opening hours at Dunstable Library, Vernon Place Dunstable LU5 4HA.

<u>High Court Challenge:</u> Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 21st February 2011 make application for the purpose to the High Court.
