- 1. This Order shall come into operation on 24th day of October 2011 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No 14) Order 2011."
- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
 - (i) The plan schedule reference "Area Code F 123: Sheet Revision Number 1" shall be deleted and "Area Code F 123: Sheet Revision Number - 2" shall be substituted.
 - (ii) The plan schedule reference "Area Code G 117: Sheet Revision Number 2" shall be deleted and "Area Code G 117: Sheet Revision Number - 3" shall be substituted.
 - (iii) The plan schedule reference "Area Code G 118: Sheet Revision Number 2" shall be deleted and "Area Code G 118: Sheet Revision Number - 3" shall be substituted.

On 14th October 2011 Central Bedfordshire Council made a Road Traffic Regulation Order as follows:

Effect of the Order:

To introduce No Waiting At Any Time on the following lengths of road in Leighton Buzzard:

- Heath Road, on the west side, from a point 4 metres north east of the common boundary between property number 47 and 49, in a north-easterly direction for a distance of approximately 40 metres.
- Heath Road, on the east side, from a point 7 metres south west of the common boundary between property number 20 and 22, in a north-easterly direction for a distance of approximately 43.5 metres.
- Clarence Road, on the north side, from a point in line with the common boundary between property number 2 and 4, in a westerly direction to Heath Road.
- Clarence Road, on the south side, from a point 10 metres west of the common boundary between property number 2 and 4, in a westerly direction to Heath Road.
- Heath Park Road, on both sides, from the boundary wall between Green Gables and Red Rooves, in an easterly direction to Heath Road.
- Sandy Lane, on both sides, from a point 18.5 metres east of the common boundary between property number 1 and 2 Sandy Lane Cottages, in an easterly direction to Heath Road.
- Chiltern Gardens (north junction with Heath Road), on both sides, from Heath Road in an easterly direction for a distance of approximately 10.5 metres.
- Chiltern Gardens (south junction with Heath Road), on both sides, from Heath Road in an easterly direction for a distance of approximately 10.5 metres.

To revoke the existing No Stopping on School Entrance, Monday to Friday, 8am to 4.30pm on the following length of road in Leighton Buzzard:-

Heath Road, on the east side, outside Heathwood Lower School.

Date of Operation: The Order will come into operation on the 24th October 2011.

<u>Further Details:</u> of the Order and a plan may be examined during normal opening hours at Leighton Buzzard Library, Lake Street, Leighton Buzzard, LU7 1RX.

<u>High Court Challenge:</u> Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 14th October 2011 make application for the purpose to the High Court.
