- 2. Creasey Park Drive, north-east side, from the north-west kerb line of Brewers Hill Road in a north-westerly direction to a point approximately 5 metres north-west of the front wall of no.14 Brewers Hill Road.
- 3. Creasey Park Drive, north-east and north-west sides, from a point approximately 1 metre southeast of the north-west flank wall of no.40 Aldbanks in a north-westerly then south-westerly direction to the end of the road.

Date of Operation:- The Orders will come into operation on the 3 March 2014.

<u>High Court Challenge</u>:- Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of 24 February 2014, make application for the purpose to the High Court.

 - (ii) The plan schedule reference "Area Code W 137: Sheet Revision Number 1" shall be deleted and "Area Code W 137: Sheet Revision Number 2" shall be substituted.
 - (iii) The plan schedule reference "Area Code X 137: Sheet Revision Number 2" shall be deleted and "Area Code X 137: Sheet Revision Number 3" shall be substituted.
 - (iv) The plan schedule reference "Area Code W 136: Sheet Revision Number 1" shall be added to the plans attached to this Order.
