On 24 February 2014 Central Bedfordshire Council made the above named Traffic Regulation Order as follows:-

To introduce No Waiting at any time on the following lengths of road in Dunstable:-

1. Creasey Park Drive, south-west and south-east sides, from the north-west kerb line of Brewers Hill Road for its full length.
2. Creasey Park Drive, north-east side, from the north-west kerb line of Brewers Hill Road in a north-westerly direction to a point approximately 5 metres north-west of the front wall of no.14 Brewers Hill Road.
3. Creasey Park Drive, north-east and north-west sides, from a point approximately 1 metre south-east of the north-west flank wall of no.40 Aldbanks in a north-westerly then south-westerly direction to the end of the road.

Date of Operation:- The Orders will come into operation on the 3 March 2014.

Further Details may be examined during normal opening hours at Dunstable Library, Vernon Place, Dunstable LU5 4HA.

High Court Challenge:- Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of 24 February 2014, make application for the purpose to the High Court.

The Central Bedfordshire Council (the "Council") in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 3rd day of March 2014 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.26) Order 2014"

2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
 - (i) The plan schedule reference "Area Code F 125: Sheet Revision Number – 3" shall be deleted and "Area Code F 125: Sheet Revision Number – 4" shall be substituted.
 - (ii) The plan schedule reference "Area Code W 137: Sheet Revision Number – 1" shall be deleted and "Area Code W 137: Sheet Revision Number – 2" shall be substituted.
 - (iii) The plan schedule reference "Area Code X 137: Sheet Revision Number – 2" shall be deleted and "Area Code X 137: Sheet Revision Number – 3" shall be substituted.
 - (iv) The plan schedule reference "Area Code W 136: Sheet Revision Number – 1" shall be added to the plans attached to this Order.
