

## BEDFORDSHIRE COUNTY COUNCIL

### Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) Waiting Restrictions and Street Parking Places) (Consolidation) (Variation No 3) Order 2008

On the 28th November 2008 Bedfordshire County Council made a Road Traffic Regulation Order as follows:

#### Effect of the Order:

#### **A. To make legal the existing Disabled Persons' Parking Places at the following locations in Albert Court, Dunstable:-**

- i. On the east side of Albert Court at a point approx 10 metres south from the centre line of the access to South Bedfordshire District Council's garages in a southerly direction for a distance of approx 4 metres.
- ii. On the west side of Albert Court at a point approx 26 metres south of its junction with King Street in a southerly direction for a distance of approx 3 metres.

The days and hours of operation of these parking places will be unrestricted for disabled persons' vehicles. These parking bays need to be made legal to ensure that disabled people are able to park at convenient locations close to the sheltered housing.

#### **B. To introduce no waiting at any time restrictions on Albert Court, Dunstable as follow:-.**

- i. On the east side of Albert Court from its junction with King Street in a southerly direction for a distance of approx 15 metres.
- ii. On the west side of Albert Court from its junction with King Street in a southerly direction for a distance of approx 25 metres.

#### As part of the Waiting Restriction Order the existing no waiting at any time restrictions on King Street, Dunstable will be removed as follows:-.

- i. On the south side of King Street, Dunstable which extends from the south west boundary of No 14 King Street in a south westerly direction for approx 23 metres.
- ii. On the south side of King Street, Dunstable which extends from the boundary of Nos 58/60 King Street in a north easterly direction for approx 54 metres to a point approx 10 metres north east of the boundary of No 65 Great Northern Road.

The restrictions in Albert Court are considered necessary to protect emergency access to the elderly people living in the sheltered housing. In addition some of the existing restrictions in King Street will be relaxed to create more parking spaces.

Date of Operation: The Order will come into operation on the 8th December 2008.

Further Details of the Order and a plan showing the lengths of road affected may be examined during normal office hours at County Hall, Bedford and normal opening hours at Dunstable Library, Vernon Place, Dunstable.

High Court Challenge: Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant Section of the Road Traffic Regulation Act 1984 or on the ground that any requirement of that Section had not been complied with in relation to the Order may, within six weeks of the 7th December 2008 make application for the purpose to the High Court.

The Bedfordshire County Council (the "Council") in exercise of the powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 8th day of December 2008 and may be cited as "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) (Variation No 3) Order 2008"
  
2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-
  - (i) The plan schedule reference "Area Code AA140: Sheet Revision Number – 2" shall be deleted and "Area Code AA140: Sheet Revision Number -.3" shall be substituted.
  
  - (ii) The plan schedule reference "Area Code AA141: Sheet Revision Number – 1" shall be deleted and "Area Code AA141: Sheet Revision Number – 2" shall be substituted.
  
  - (iii) The plan schedule reference "Area Code Z141: Sheet Revision Number – 1" shall be deleted and "Area Code Z141: Sheet Revision Number – 2" shall be substituted.
