The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

- This Order shall come into operation on 15th day of January 2016 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.46) Order 2016"
- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To add No Waiting at any time on the following length of road in Shefford:-

- a) School Lane, both sides, from a point approximately 3 metres south of the front wall of no.89 Ampthill Road extending in a southerly direction to a point approximately 3 metres south of the boundary of no.89 Ampthill Road and no.1 School Lane.
- b) School Lane, east side, from a point approximately 3 metres north of the southern property boundary of no.9 School Lane extending in a southerly direction to the end of the road including both sides of the eastern spur road to the school.
- c) School Lane, west side, from a point in approximately 3 metres north of the southern property boundary of no.9 School Lane extending in a southerly direction to the end of the road.

To add No Waiting Monday to Friday from 8.00am to 9.30am and 3.00pm to 4.30pm on the following length of road in Shefford:-

- a) School Lane, both sides, from a point approximately 3 metres south of the boundary of no.89 Ampthill Road and no.1 School Lane extending in a southerly direction to a point approximately 3 metres north of the southern property boundary of no.9 School Lane.
- b) Ampthill Road, north side, from a point approximately 3 metres east of the boundary of nos.76 and 78 Ampthill Road extending in a westerly direction to a point approximately 3 metres west of the boundary of nos.86 and 88 Ampthill Road.
