The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

- 1. This Order shall come into operation on 16th day of August 2017 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.47) Order 2017"
- 2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To add Parking for Resident Permit Holders only on the following length of road in Dunstable:-

(i) Stuart Street, from a point 4 metres north-west of the front wall of no.66 Union Street extending in a north-westerly direction to a point in line with the front wall of no.37 Clifton Road.

To add No Waiting at any time on the following lengths of road in Dunstable:-

- (i) Stuart Street, both sides, from its junction with Union Street extending in a north-westerly direction to a point approximately 4 metres north-west of the front wall of no.66 Union Street.
- (ii) Stuart Street, both sides, from its junction with Clifton Road extending in a south-easterly direction to a point in line with the front wall of no.37 Clifton Road.
- (iii) Clifton Road, south-east side, from a point in line with the south-west flank wall of no.37 Clifton Road extending in a south-westerly direction for approximately 15 metres.

To remove the existing No Waiting at any time and introduce 30 minutes Limited Waiting with No Return within 1 hour from 8am to 6pm on the following length of road in Dunstable:-

(i) Union Street, north-west side, from a point approximately 2 metres north-east of the boundary of nos.68 and 70 Union Street extending in a south-westerly direction for approximately 15 metres.

To remove the existing No Waiting at any time on the following length of road in Dunstable:-

(i) Union Street, north-west side, from a point approximately 2 metres south-west of the boundary of nos.64 and 66 Union Street extending in a north-easterly direction for approximately 32 metres.
