ENFORCEMENT AREA) (WAITING RESTRICTIONS) (CONSOLIDATION) ORDER 2008)
(VARIATION NO.50) ORDER 2017

The Central Bedfordshire Council (the "Council") in exercise of its powers under sections 1(1), 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on 8th day of January 2018 and may be cited as "Central Bedfordshire Council (Bedfordshire County Council (District of South Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008) (Variation No.50) Order 2017
2. As from the date upon which this Order comes into operation, the provisions of the "Bedfordshire County Council (District of Mid Bedfordshire) (Civil Enforcement Area and Special Enforcement Area) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2008" shall be varied as follows:-

To introduce No Waiting at any time on the following lengths of road in Leighton Buzzard:-

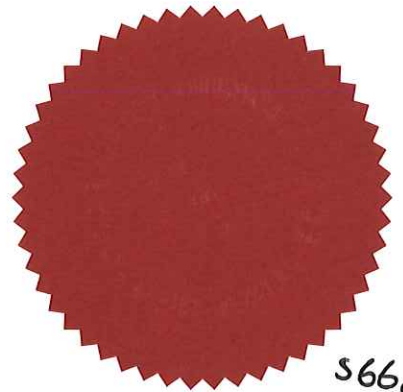
- (i) Cedars Way, south-west side, from a point approximately 5 metres north-west of a point in line with the boundary of nos.12 and 14 Cedars Way extending in a north-westerly direction for approximately 22 metres.
- (ii) Wyngates, both sides, from its junction with Cedars Way extending in a south-westerly to a point approximately 6 metres north-east of the north-east flank wall of no.3 Wyngates.
- (iii) Wyngates, north-west side, from a point approximately 14 metres south-east of the northeast flank wall of no.3 Wyngates extending in a south-westerly direction for approximately 17 metres.
- (iv) Wyngates northern spur (adjacent to property nos.2-10), east side, from the north-west kerbline of Wyngates extending in a generally northerly direction for approximately 17 metres when measured along the road edge.
- (v) Wyngates northern spur (adjacent to property nos.2-10), west side, from the north-west kerb line of Wyngates extending in a generally northerly direction for approximately 51 metres when measured along the road edge.

To introduce 2 hours Limited Waiting with No Return within 2 hours from Monday to Friday between 8am and 6pm on the following lengths of road in Leighton Buzzard:-

- (i) Wyngates, north-west side, from a point approximately 6 metres north-east of the northeast flank wall of no.3 Wyngates extending in a south-westerly direction for approximately 20 metres.
- (ii) Wyngates northern spur (adjacent to property nos.2-10), west side, from a point approximately 17 metres north of the north-west kerb line of Wyngates extending in a northerly direction for approximately 20 metres (8 parking bays marked perpendicular to the road).
- (iii) Wyngates northern spur (adjacent to property nos.2-10), northern end, from a point approximately 51 metres north of the north-west kerb line of Wyngates extending in an easterly direction for approximately 5 metres (2 parking bays marked at the far end of the road).
